TYPICAL DUTIES

The Deputy County Surveyor is responsible for assisting in the administration of the County Surveyor's Office. This position will perform responsible, professional and supervisory work in the direction of the operations and functions of the Office. This position will function as a manager and will be responsible for planning, coordinating, directing and supervising the work of a the Surveyor's Office.

Once this position is filled, the Department of Public Works will present and recommend to the Board of Supervisors that the incumbent be designated as the County Surveyor. Pending Board approval, the Deputy County Surveyor will be expected to fulfill the duties associated with this designation. This assignment is typically provided special assignment pay in the amount of 5% of base salary.
