Testing for the following positions will tentatively occur as follows:

Deputy Fire Marshal	March 31 - April 1, 2023	Life Safety Compliance Officer	March 31 - April 1, 2023

The test date for each job title is dependent on the number of applications we receive for each position. However, only two tests will occur on each date specified. Also, please be advised the report time anticipated for the March 31st date will be in the late afternoon, with the exam process concluding during the evening. The test information listed above is the official test notice.

When the application period closes, we will contact eligible applicants to confirm all test dates. For personal planning purposes, it is important for all potential applicants to know that testing is planned to occur on these dates. If you plan to apply, please arrange your schedule accordingly so that you will not have a conflict. If you are planning to apply to more than one position, you must submit a separate application for each position.

An examination invite will be sent to all eligible applicants quickly after the application period closes. The invite will confirm the test dates and will contain information such as test times, location, and instructions on how to RSVP participation in the examination process. Eligible applicants will be required to RSVP by a prescribed deadline date to participate in the examination process. That deadline date and further instructions on who to contact will be contained in the examination invite. Please note that there will be a significantly shorter time period allowed to RSVP your participation in the exam process for any of these positions. Please plan on responding quickly. Communication with all applicants will be by email. Please be sure to supply an email address that you check regularly when you apply.

Because of the nature of the exam processes for the positions above, no reading or study material is being provided. The exams will be designed so that any information you need will be provided to you in the exam exercises. There will be a candidate orientation video link that will be sent to all eligible applicants on March 25th. The goal of this orientation is to inform you of what to expect in the examination process.
