About the Position

The Department of Public Works (Department) is seeking a dynamic individual to fill a senior level engineering position (Engineer V) in the Water Resources Division. The successful candidate will work directly with the Water Resources Manager on current water resources efforts. The Engineer V will assist the Water Resources Manager with groundwater and surface water management; including water rights; Sustainable Groundwater Management Act (SGMA) compliance efforts, agricultural and urban water conservation; groundwater modeling; CEQA/NEPA and related regulatory and permitting requirements for water resources projects.



About the Department

The Department has over 450 employees who are responsible for planning, designing, constructing, operating, and maintaining the County's public roads and bridges, public utility systems (water, wastewater, storm drainage, and streetlights), flood control facilities, solid waste facilities, and fleet vehicles. The Department provides quality service to the community to protect the health and welfare of the public and preserve the County's infrastructure investments. The Department's vision is being a leader in identifying and adopting processes that result in efficient and effective service to County constituents. Typical Duties

- Supervises and directs subordinate engineering, administrative and technical personnel in the planning, development, design and construction of a variety of public works projects and programs.
- Reviews and approves plans, specifications, and cost estimates for a variety of construction projects; plans and conducts feasibility studies for a variety of projects including water, flood control, drainage, traffic, road, and bridge projects.
- Consults with management and administration regarding the establishment of engineering policies and procedures in the department and for the County; recommends establishment of division policies, procedures, training and related activities.
- Confers with, advises and supervises engineers in charge of projects; supervises enforcement of contractual obligations; coordinates a variety of Public Works projects with other agencies.
- Gives technical engineering advice and may confer with other County officials, department heads, colleagues and contractors as directed.
- Represents the department and acts as liaison with other governmental agencies, contractors, and the public regarding general engineering matters and problems; may attend Planning Commission or other meetings.
- Prepares ordinances and resolutions regarding Public Works functions for action by the Board of Supervisors.

Major Responsibilities

1. Collects, manages, analyzes and reports all groundwater and water resources data; maintains the groundwater monitoring network.
2. Coordinates regulatory compliance and permitting on water resource projects and programs.
3. Supports projects and planning efforts to address groundwater overdraft and achieve groundwater sustainability, including those efforts related to SGMA; and Integrated Regional Water Resources Planning.
4. Supports County involvement in protecting the Delta and works closely with state and federal agencies.
5. Participates in efforts to develop, protect and maintain county water rights.
6. Coordinates staff and consultants as necessary for complex investigations, engineering feasibility studies, project formulation, contract scope and fee negotiation, preparation of engineering plans and specifications, or other documents as required; monitors consultant contract provisions; recommends and develops changes as appropriate.
7. Mentor and lead a professional staff with collaborative, supervisory and managerial skills.
8. Identifies and resolves complex problems by conferring with customers, colleagues, consultants, contractors, industry experts and others regarding project and/or program

License & Certificates: (1) Possession of a valid certificate of registration as a Civil Engineer or Traffic Engineer as issued by the California Board of Registration for Professional Engineers and Land Surveyors; (2) Possession of a valid California driver's license.

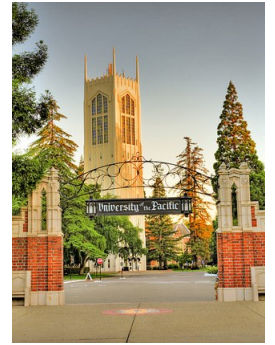

Education
